I hereby certify that:

- When solid carbon dioxide (dry ice) is used for cooling purposes, the container is externally marked or labelled in a conspicuous place at the door end, reading: "DANGEROUS CO2-GAS(DRY ICE) INSIDE. VENTILATE THOROUGHLY BEFORE ENTERING."
- The dangerous goods declaration required in sub-section 9.4 of the General Introduction to the International Maritime Dangerous Goods (IMDG) code has been received for each dangerous goods consignment packed in the container.
- If the consignments include goods of Class 1, except Division 1.4, the vehicle container is structurally serviceable in conformity with Section 1.4 of the introduction to Class 1 of the IMDG Code.
- When dangerous goods are transported in bulk packagings, the cargo has been evenly distributed.
